4. Inspect flue pipe and draft diverter
5. Check operation of safety controls
6. Clean and adjust burners
7. Test and adjust gas pressure
8. Clean interior of manifold equipment
9. Check and adjust belt tension
10. Lubricate all necessary parts
11. Check baffles and inspect heat exchanger
12. Clean and adjust thermostat
13. Test for gas leaks in furnace
14. Clean and adjust pilot
15. Check sequencer
16. Check heating elements
17. Check furnace in operation
18. Check CO level

ALSO INCLUDED WITH OIL FURNACES AND BOILERS

1. Replace oil nozzle
2. Replace oil filter
3. Check ignition controls
4. Adjust draft regulator
5. Clean and check fill valve
6. Drain expansion tank

COOLING SYSTEMS / HEAT PUMP SYSTEMS

1. Check air filters
2. Tighten electrical connections
3. Check operating pressures
4. Check operation of safety controls
5. Inspect contactor contacts
6. Clean and check condenser coil
7. Check and record super heat
8. Check and adjust belt tension
